Applications are invited from eligible Indian citizen as defined in Article 5 to 8 of the Constitution | of India and permanent residents of Assam for filling up 1424 vacancies of Post Graduate | Teachers in the different Provincialised Secondary Schools under the Directorate of | Secondary Education, Assam in the scale of pay of Rs.22,000/ - to 97,000/- including Grade | Pay of Rs. 11,800 /- PM (under Pay Band- 3) plus other allowances as admissible under Rules. |

The District-wise, subject-wise, medium-wise and category-wise posts details as well as date and time of receipt of online applications for TET cum Recruitment Test and other details will be notified in the official website at www.madhyamik.assam.gov.in in due course of time. The aspiring candidates must be ready to serve in their respective places of posting in terms of choice of their Districts.

### ➢ CONDITIONS OF RECRUITMENT:-

### Academic and professional Qualifications:

- i. The applicant must be a Post Graduate in concerned subject with at least 50% marks (or its equivalent) from recognized University and should possess Bachelor of Education (B.Ed.) qualification from an institution recognized by National Council for Teacher Education. Degrees obtained in off-campus and distance education mode shall not be considered as valid.
- ii. The candidate shall have to read the same subject as one of the subjects in degree level.
- iii. In addition to the academic and professional qualification, the applicant must satisfy the following criteria;

(a) In case of Assamese Medium School, the applicant must have passed HSLC or | equivalent examination with Assamese language as one of the subjects or have diploma | in Assamese Language issued by the Assam Sahitya Sabha or read up to HSLC level | in Assamese Medium School.

- (b) In case of Bengali Medium School, the applicant must have passed HSLC or equivalent examination with Bengali language as one of the subjects or have Diploma in Bengali issued by the Barak Upatyaka Bangya Sahitya O Sanskriti Sammelan or read up to HSLC level in Bengali Medium School.
- (c) In case of Hindi Medium School, the applicant must have passed HSLC or equivalent examination with Hindi language as one of the subjects or read upto HSLC level in Hindi Medium School.
- (d) In case of Bodo Medium School, the applicant must have passed HSLC or equivalent examination with Bodo language as one of the subjects or read upto HSLC level in Bodo Medium School.
- (e) In case of English Medium School, the applicant must have passed HSLC or equivalent | examination with alternative English as one of the subject or read from Class XI onwards | in English Medium School.

Provided that for recruitment of teachers for teaching MIL subjects the candidate who passed HSLC Examination with particular MIL Subject shall be considered.

- 6. No offline application will be accepted in this regard.
- 7. The Online Applications and documents submitted by the candidates will be verified along with their original testimonials before appointment. The detailed schedule and venue for Screening/ Verification of documents will be notified in the official website. No TA/DA is admissible for verification process. Verification will be conducted simultaneously for all the Districts and the candidates will be informed either individually or collectively by the Director of Secondary Education, Assam in the official website.
- 8. The Online Applications and documents submitted by the candidate will be verified using modern technology with the help of DigiLocker, Govt. of India and by scanning Barcode or QR Code for ensuring genuineness of the uploaded documents as well as by back office verification with the competent board/ council/ authority. But the authority if desires may conduct physical document verification at any point of time with proper notice.
- 9. The candidate must ensure genuineness of all the information/ documents uploaded against the online application and he/ she will be solely responsible for the information/ documents uploaded against his/ her online application. Once uploaded there will be no scope of correction in respect of the credential submitted by the candidate. Any discrepancy will lead to cancellation of the candidature.
- 10. The candidature will be cancelled forthwith, if any kind of fraudulence/ discrepancy regarding any information / documents uploaded by the candidate is established by appropriate authority at any point of time.
